



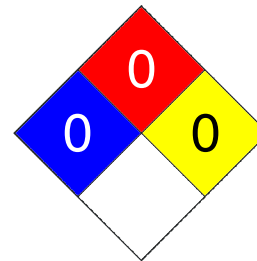

**First aid procedures**

**Inhalation** If symptoms develop move victim to fresh air. If symptoms persist, obtain medical attention.
